The Elimination of Doctors and the Denial of Healthcare – in America!

No, that’s not a quote from a B-grade movie, it’s the communitarian (read Communist) quotes, summarized, of Dr. Ezekiel Emanuel and Dr. David Blumenthal, both Jews, and both key health advisors to former President Barack Obama, also a Jew (his mother was a Jew).

Emanuel is the brother of former White House Chief of Staff Rahm Emanuel (for Barack Obama), former Chicago mayor. He was appointed to two key positions: health-policy adviser at the Office of Management and Budget and a member of the Federal Council on Comparative Effectiveness Research. Obama appointed Blumenthal to be the national coordinator of health-information technology to make sure **doctors obey computer decisions** of what “care” the government deems “appropriate and cost effective.”

Michael Bloomberg’s philosophy on treating the elderly

Billionaire and former Democratic presidential candidate Michael Bloomberg said in a 2011 video that elderly cancer patients should be denied treatment in order to cut health care costs. “All of these costs keep going up, nobody wants to pay any more money, and at the rate we’re going, health care is going to bankrupt us,” said Bloomberg, who was then New York City’s mayor.

“We’ve got to sit here and say which things we’re going to do, and which things we’re not, nobody wants to do that. Y’know, if you show up with prostate cancer, you’re 95 years old, we should say, ‘Go and enjoy. Have a nice [inaudible]. Live a long life. There’s no cure, and we can’t do anything.’ If you’re a young person, we should do something about it,” Bloomberg said in the video.

Many people think they don't mean what they say. They think they are just trying to say we have to cut medical expenses, but the real goal is eventually to deny **all** medical care, except for the elitists. After all, when the "Plan" for America and the World is Population Extermination from the present 7 billion inhabitants in the world, down to 500 million, why would the New World Order want to keep anyone alive and healthy – except themselves.

Dr. Emanuel is now 63 and Dr. David Blumenthal is 73, yet we don't hear either one of them describing themselves as "useless eaters."

Telemedicine: Elimination of Physicians in America

Two-way interactive television (IATV) uses video-teleconferencing equipment to create a "meeting" between a patient and primary care physician (or a physician's assistant or nurse practitioner) in one location and a physician specialist elsewhere when a face-to-face consultation is not feasible because of time or distance. How rapidly that has arrived with that HOAX Covid-19 Scamdemic! Peripheral equipment even enables the consulting physician specialist to perform a "virtual physical examination" and hear the patient's heart sounds through a stethoscope. The availability of desktop videoconferencing has expanded this form of telemedicine from a novelty found exclusively in urban, university teaching hospitals to a valuable tool for patients and physicians in rural areas who were previously underserved and unable to access specialists readily.

All of that sounds wonderful and helpful to society. However, this type of technology will ultimately be directed towards eliminating virtually ALL physicians in America except a few specialists in New York City and Boston. Nurse practitioners (NP) and/or physician assistants (PA), who have 5-7 LESS years of training than doctors, will run all the medical clinics, and these physician "specialists" will be involved only rarely, when the NP or PA has no other choice.

Eventually, even the Nurse practitioners and Physician assistants will be phased out and replaced with Walmart or Drug Store Cashiers who have been given 2 weeks training on how to take a pulse, listen to the lungs with a stethoscope, and hook up EKG leads to record the electrocardiogram (that will be analyzed and read by a computer).

NIH Consensus Development Program

Over 40 years ago, the National Institutes of Health, the government overseer of virtually all disease and health "advances" and medical research, began the Consensus Development Program. Every diagnosis imaginable was examined by experts brought together by the NIH for what appears to be the express purpose of creating a specific – an inviolable – protocol for every step in the "treatment" of every disease and disorder known to man. The goal is to codify ALL diagnoses and treatment, allowing no health care provider to vary, in the minutest detail, from the established protocol. That means

your healthcare provider could be a baboon, and you would get “adequate” healthcare, according to your government

Computer Technology

These Consensus Protocols can then be computerized, allowing a PA or NP (or eventually a two week-trained cashier) to give a form to a patient who records their symptoms and medical complaints. That form can then be run through the computer and out the other end comes a diagnosis, complete with the treatment protocol developed over the years by expert committees brought together by the NIH.

The treatment protocol in 90%-95% of patients will be a drug – or a number of drugs, which can then be dispensed by the pharmacist through a prescription written by the computer.

Only in rare cases will the patient need to be seen by a real physician, and this is where telemedicine comes in. An appointment will be made by computer with one of the designated specialty doctors in New York, Los Angeles, and possibly Chicago, and the patient will return for a “virtual” examination by that physician. Eventually, all the doctors at these large city locations will be Jews and will use Talmudic law to make their decisions about who lives and who dies.

Here is what the Talmud says about Jewish doctors treating “Gentiles.” The following is an excerpt from the book, Jewish History, Jewish Religion, by Jewish author, Israel Shahak, Chapter 5, The Law Against Non-Jews:

“In particular, a Jewish doctor must not treat a Gentile patient. Maimonides - himself an illustrious physician - is quite explicit on this; in another passage (18) he repeats the distinction between 'thy fellow' and a Gentile, and concludes: 'and from this learn ye, that it is forbidden to heal a Gentile even for payment...'

“However, the refusal of a Jew - particularly a Jewish doctor - to save the life of a Gentile may, if it becomes known, antagonize powerful Gentiles and so put Jews in danger. Where such danger exists, the obligation to avert it supersedes the ban on helping the Gentile. Thus Maimonides continues: ' ... but if you fear him or his hostility, cure him for payment, though you are forbidden to do so without payment.' In fact, Maimonides himself was (Islamic General) Saladin's personal physician. His insistence on demanding payment - presumably in order to make sure that the act is not one of human charity but an unavoidable duty - is however not absolute. For in another passage he allows a Gentile whose hostility is feared, to be treated 'even gratis, if it is unavoidable.'

“The whole doctrine - the ban on saving a Gentile's life or healing him, and the suspension of this ban in cases where there is fear of hostility - is repeated (virtually verbatim) by other major authorities, including the 14th century Arba'ah Turim and Karo's Beyt Yosef and Shulhan 'Arukh. Beyt Yosef adds, quoting Maimonides: 'And it is

permissible to try out a drug on a heathen (Gentile), if this serves a purpose'; and this is repeated also by the famous R. Moses Isserles.

“The consensus of halakhic (Jewish law) authorities is that the term 'Gentiles' in the above doctrine refers to all non-Jews.

Wal-Mart Medical Clinics

There are already 78 medical clinics operating around the U.S. in Walmart stores. In the next several years, 400 more medical clinics will be opened. CVS Pharmacies and some Big Box Stores are also planning to open their own medical clinics. At the present time, these are staffed by physicians and assistants from local hospitals but this is causing discomfort among the physicians and hospitals who understand that they are undermining their own business by their cooperation with Wal-Mart and the others. Since medical care will be automated and computerized, it won't be long until the PA's and NP's running these clinics will be briefly-trained Wal-Mart store clerks, assisted rarely by the Jewish physician specialists in New York, thus holding complete control over the “healthcare” of everyone in America, and deciding who gets treated and who doesn't.

In fact, Wal-Mart may well be the ONLY store of the future and will provide: food, clothing, sports clothing and supplies, gardening equipment and supplies, vision services, medical clinics, psychological counseling, tires, gasoline stations, and probably mechanics, and dentists will be added eventually.

It will truly be “One-Stop Shopping.”

And because Wal-Mart will have no competition, the quality of goods and services will continue to go down.

Decrease in Physician's salaries

In 2012, physicians and other healthcare practitioners absorbed another stiff cut in Medicare and Medicaid fees, a cut of 30%. More than 1 million providers of services to Medicare beneficiaries were affected, including medical and osteopathic physicians, limited license practitioners such as podiatrists, nurse practitioners and physical therapists.

This is the eleventh time a payment cut has been instituted by Medicare. As the reimbursement for physicians goes down, the increasing paperwork required goes up, including the draconian laws on patient privacy that are so demanding that it's even difficult for the patient himself to have access to his own medical records. This increasing paperwork requires more personnel to handle it, significantly increasing the overhead of the physician. In addition, patients are more litigious, raising malpractice rates to record heights. AAOS Now, August 2011, p 30.

The bottom line is that soon physicians will not be able to practice medicine because their overhead will be greater than their income.

And that is exactly what the New World Order wants: to break the back – financially - of the middle, and upper middle, class in America, and to discourage anyone from practicing medicine.

Availability of Vaccinations

Vaccinations are now being given at drug stores, grocery stores, department stores, and in other business facilities. How are those who give the vaccinations trained? Do they always use a new needle? Are the old, used needles discarded safely? Do they “draw” the vaccination fluid from a multi-use vial that may be contaminated by a previous needle used in the solution? Are those trained in injecting the vaccines taught anatomy so they can avoid hitting a nerve either in the upper arm or in the buttocks? Dumping toxins on the Third World

“In the aftermath of the most recent unnecessary Pandemic declaration of a global H1N1 swine flu emergency, industrial countries were left sitting on hundreds of millions of doses of untested vaccines. They decided to get rid of the embarrassing leftover drugs by handing them over to the World Health Organization (WHO) that in turn plans to dump them for free on select poor countries. France has given to the WHO 91 million of the 94 million doses the Sarkozy government bought from the pharma giants; Britain gave 55 million of its 60 million doses. The story for Germany and Norway is similar.

“As Dr. Thomas Jefferson, an epidemiologist with the Cochrane Research Center in Rome noted, "Why do they give the vaccines to the developing countries at all? The pandemic has been called off in most parts of the world. The greatest threat in poor countries right now is heart and circulatory diseases while the virus figures at the bottom of the list. What is the medical reason for donating 180 million doses?" As well, flu is a minor problem in countries with abundant sunshine, and it turned out that the feared H1N1 Pandemic "new great plague" was the mildest flu on record.

“The pharmaceutical vaccine makers do not speak about the enormous health damage from infant vaccination including autism and numerous neuro-muscular deformities that have been traced back to the toxic adjuvants and preservatives used in most vaccines. Many vaccines, especially multi-dose vaccines that are made more cheaply for sale to the Third World, contain something called Thimerosal (Thiomersol in the EU), a compound (sodium ethylmercurithiosalicylate), containing some 50% mercury, used as a preservative. Mercury is a severely toxic ingredient that causes cancer, brain and kidney damage, and severe damage to a developing fetus! Mercury has been used in many vaccines used in the United States as well.

“In July 1999 the US' National Vaccine Information Center declared in a press release that, "The cumulative effects of ingesting mercury can cause brain damage." The same month, the American Academy of Pediatrics (AAP) and the Centers for Disease Control and Prevention (CDC) alerted the public about the possible health effects associated with thimerosal-containing vaccines. They strongly recommended that thimerosal be removed from vaccines as soon as possible. Under the directive of the FDA Modernization Act of 1997, the Food and Drug Administration also determined that infants who received several thimerosal-containing vaccines might be receiving mercury exposure over and above the recommended federal guidelines.

A new form of eugenics?
